**OLD BUSINESS:**

Fire Truck sold to John Nolan – Discussed disposition of truck – will we fix or return his money. Our bid sheet indicated it pumped 750 gal/hr. but it won’t pump because the pipe from tank to pump is split. Tank won’t hold water and oil is draining out of gauges.

**Mitchell/Mundt to send fire truck to Scientific in Alpena to get a bid for repair. 3 ayes. 1 nay. Motion carried.**

**NEW BUSINESS:**

Luzerne Fire Dept. budget – Over budget by \$3300 in fire runs; overall budget down to \$2500. Waiting for payment from Consumers for July standby – about \$3000 – and about \$800 for hazmat call in December. We need to transfer money from GF to fire department fund to cover costs.

**Booth/Mundt to transfer \$4000 from General Fund general government equipment line to Fire Fund. All ayes. Motion carried.**

Cemetery – Joseph Byler Jr. has been contacted and is willing to do openings/closings for us, \$400 per open/close.

**Mundt/Mitchell to contract with Joseph Byler Jr. to do cemetery opening/closings. All ayes.  
Motion carried.**
