• Katherine Burkholder – Consumers Power re: electrical meter Consumers is installing new smart meters, and expect to have the county done by the end of the year. The new meter will provide a daily meter read report. Customers can go on line to view usage, Consumers can also determine much easier who is involved when there is a power outage.

Each meter will require approximately 5 minutes for installation. Residents can opt out, but there is a \$69.39 one-time fee per meter that isn't changed, and a \$9.72 charge per month to read the meter.
