BUDGET WORKSHOP FOR 2017-2018 BUDGET

Discussion on elected official salaries for 2017-18. Concensus of opinion to give a 3% raise (rounded to next even number) for elected officials since no increase was granted in 2016. Some discussion on Assessor salary after comparison with contract prices in other townships in the county. We are currently paying just over \$5.00 per parcel while other townships are paying from \$8.00 to \$11.00 per parcel. If we have to go to contract in the future the price will likely be double what we paid during FY 2016-17.

Booth/Mitchell to place the \$4699 received for the sale of Northwoods Club property into a building fund. All ayes. Motion passed.

2017-2018 Budget Hearing to be held prior to the March Board Meeting. Will be at 6:30 p.m. on March 23, 2017.
