Sewer Authority – Approved replacing a water line to a residence in Mentor where there was a problem.

BLIGHT OFFICER REPORT

Issued 11 citations. One individual will be getting a 3rd citation. One Court action. Coulon will contact the county clerk's office regarding why we aren't receiving ticket money.

- □ Consumers Energy Heating upgrade Work to be done right after July 4th. No update on insulation.
- □ Thompson Road Engineering & Pierce Road update Contractor will do Pierce Road this summer when they are working in the County. Thompson Rd. Engineering restarted; there is an issue with the property owner where the easement is located. There will be a

meeting with the landowners and engineers to move forward with easements. Bids are coming in considerably higher this year so C2AE can't guarantee the price they gave us last year.
