- Marihuana ordinance revision Per Kristi, the ordinance proposed referred specifically to specific parts of the law, rather than the law as revised, which would require amendments to our ordinance whenever the law was amended. Also did not refer to the amounts of each category of license we were authorizing, and gives Clerk more authority than intended. She recommends we not change our ordinance at this time. No additional action was taken.

## **NEW BUSINESS:**

- Bob Whittaker re: Luzerne American Legion petition for Class C liquor license No available Class C licenses available in the county. The Luzerne Am. Legion is trying to increase their revenue and felt with the closing of some of the local establishments possibly they would be able to make becoming for-profit profitable. Whittaker soliciting approval from the Board for them to go ahead if they decide they want to make the application. Property taxes will probably be \$4000 to \$5000. Lengthy discussion on repercussions of switching from Club License to Class C. The Board will do more investigating and get back with Whittaker before a resolution is made.
- Comstock Park playground renovation No satisfaction with the original company, so McGregor has contacted the other company about their equipment and is still waiting for information.
